At a Convention of Royal Arch Masons, held in the town of Fayetteville, on Friday, the 21st June, 1822, were present the following delegates :

Companion Freeman was called to the Chair, and Companion Hunter appointed Secretary.

*Resolved, unanimously,* That it is expedient to establish a Grand Chapter of Royal Arch Masons, for and within the State of North Carolina.

*Resolved,* That Companions Arnold, Hunter, Morgan, Cash and MacRae, be appointed a committee to draught regulations for the government of the Convention.

*Resolved,* That Companions Strange, Hunter, MacRae, Dismukes, Morgan and Freeman, be appointed a committee to draught and report at the next sitting of the Convention, a Constitution for the Grand Chapter of North Carolina.

*Resolved,* That one delegate from each Chapter, not at present represented, shall compose a part of the foregoing committee, should any such delegate arrive previous to its sitting.

Convention then adjourned until to-morrow, 9 o'clock.

SATURDAY, June 22, 1822.

Convention met according to adjournment. Companion Dismukes was called to the Chair, and Companion B. B. Hunter appointed Secretary. All the members of the Convention present.

The committee appointed to draught regulations for the government of the Convention, reported the following, which was read and approved.

1. 'The chairman shall put all questions which are moved and seconded, decide all rules of order, and in case of dissatisfaction, appeal may be had to a majority of the House, and should there be a tie, he shall then be entitled to the casting vote.

2. 'All questions shall be decided by a majority, each Chapter being entitled to three votes.

3. 'Any subject may be reconsidered, and upon motion made and seconded, a majority concurring therewith.

The report of the committee, to draught a constitution for the Grand Chapter of North Carolina was read, and after sundry amendments adopted, as follows, to-wit:

## ARTICLE I.

The Grand Chapter shall consist of a Grand High Priest, Deputy Grand High Priest, Grand King, Grand Scribe, Grand Treasurer, Grand Secretary, Grand Chaplain and Grand Marshal, and likewise of the High Priests, Kings and Scribes, for the time being, of the several Subordinate Chapters under this jurisdiction, and the Past Grand and Deputy Grand High Priests, Kings and Scribes of said Grand Chapter, and the said enumerated officers, or their proxies, shall be the only members and voters in said Grand Chapter; and no individual member shall be entitled to more than one vote, either as proxy or otherwise.

## ARTICLE II.

The Grand Chapter shall be holden on the 23d day of June annually in the towns of Fayetteville and Tarboro', alternately, and the Grand or Deputy Grand High Priest, respectively, for the time being, may at any time call special meetings to be holden at such time and place as they shall severally think proper to appoint.

## ARTICLE III.

The officers of the Grand Chapter shall be chosen annually, by ballot, on the 23 day of June.

## ARTICLE IV.

Every Chapter of Royal Arch Masons and Lodge of Mark Master Masons, within this State, shall have a warrant of constitution from the Grand Chapter, under the seal thereof, and under the sign manual of its Grand or Deputy Grand High Priest, King and Scribe, and attested by its Secretary, or Letters of Dispensation from the Grand or Deputy Grand High Priest; and no Chapter or Lodge shall be deemed legal, without such warrant or letters of dispensation; and masonic communication is hereby interdicted and forbidden, either in public or privately, between any Chapter or Lodge, under this jurisdiction, or any member of either of them, and any Chapter, Lodge or Assembly, that may be so illegally formed, opened or holden, or any member of either of them, or any person exalted or advanced in such illegal Chapter, Lodge or Assembly. But nothing in this article shall be construed to affect any Chapter or Lodge which has been hitherto legally established.

## ARTICLE V.

The Grand and Deputy Grand High Priests, severally, shall have the power and authority whenever they shall deem it expedient, during the recess of the Grand Chapter, to grant Letters of Dispensation, under their respective hands

and private seals, to a competent number of petitioners possessing the qualifications required by the 9th section of the 2d article of the General Grand Royal Arch Constitution empowering them to open a Chapter of Royal Arch Masons and Lodge of Most Excellent, Past, and Mark Master Masons, for a certain specified time: *Provided*, That the said term of time shall not extend beyond the next stated meeting of the Grand Chapter; and *provided further*, That the same fees as are hereinafter required for a warrant of Constitution shall have been deposited with the Grand Treasurer; and, in all cases of such Dispensation, the officer granting the same, shall make report thereof to the next stated meeting of the Grand Chapter; when the Grand Chapter may either continue or recall such Dispensation, or grant the Petitioners a warrant of Constitution, in which latter event, the fees first deposited shall be credited in payment for the same. But if a warrant shall not be granted, nor the Dispensation continued, the said fees shall be refunded to the Petitioners, except such part thereof as shall have been actually expended by reason of their application.

#### ARTICLE VI.

Upon every application for a warrant or charter from this Grand Chapter, to constitute a new Chapter, there shall be advanced and paid to the Grand Treasurer thereof, the sum of seventy-five dollars before said warrant or charter shall be issued; whereof, the Grand Secretary shall receive ten dollars by way of compensation for furnishing parchment for said charters or warrants, and having the same elegantly printed or written.

#### ARTICLE VII.

The several subordinate Chapters in this State, shall each pay this Grand Chapter, the sum of fifteen dollars annually.

#### ARTICLE VIII.

No warrant for the institution of a new Chapter of Royal Arch Masons, shall be granted, except upon the petition of nine regular Royal Arch Masons, which petition shall be accompanied by a certificate from the Chapter nearest to the place where the new Chapter is intended to be opened, vouching for the moral characters and masonic abilities of the petitioners, and recommending to the Grand Chapter to grant their prayer. And no warrant for the institution of a Lodge of Mark Master Masons shall be granted, except upon the petition of at least five regular Mark Master Masons, accompanied by vouchers from the nearest Lodge of that degree or Chapter of Royal Arch Masons, similar to those required at the institution of a Chapter.

## ARTICLE IX.

The Grand Secretary of this Chapter shall make an annual communication to each of the Grand Secretaries of the several Grand Chapters working under the authority of the General Grand Chapter of the United States; and also the General Grand Secretary, containing a list of the Grand Officers, and all such other matters as may be deemed necessary or useful for the mutual information of said Grand Chapters: And the said Grand Secretary shall also regularly transmit to the General Grand Secretary a copy of the Bye-Laws and Regulations of this Grand Chapter, with the amendments thereto.

## ARTICLE X.

The Secretaries of the several subordinate Chapters and Lodges shall make report to the Grand Chapter, at its annual meeting, of all such advancements, exaltations, resignations, suspensions or expulsions, as may have taken place in his Chapter, during the year, and shall, at the same time, transmit the annual dues, with a list of officers and members.

## ARTICLE XI.

No subordinate Chapter, or Lodge, shall confer any degree within their Chapter, but upon application in writing, filed at least one month for consideration, nor unless after such consideration, upon ballot, there shall be an unanimous vote in favor of the petitioners, and no member voting in the negative, upon such application, shall be required to assign his reasons.

## ARTICLE XII.

Any member of a subordinate Chapter, or Lodge, dissatisfied with a decision thereof, in which he is personally interested, shall have the right of appeal to the Grand Chapter: and it shall be the duty of the Secretary of such Chapter or Lodge to transmit to the Grand Chapter, at its next session after such appeal shall be prayed, intimation of such appeal, with an official statement of the circumstances of the case, countersigned by the High Priest, or other presiding officer of such Chapter or Lodge: and the person officiating as the presiding officer, when such dissatisfaction occurred, is hereby required to countersign said statement.

## ARTICLE XIII.

When any person who is an officer of any subordinate Chapter, or Lodge, under the jurisdiction of this Grand Chapter, shall be elected Grand, or Deputy Grand High Priest, Grand King or Grand Scribe, it shall be *de facto* a vacation of his office, in such subordinate Chapter or Lodge, so long as he shall retain such Grand Office.



## ARTICLE XIV.

Whenever there shall be a dissolution of any one of the Chapters under this jurisdiction, or whenever any such Chapter shall incur a forfeiture of its charter ; in either of those cases, the funds and furniture at that time belonging to such Chapter, shall become, and are hereby declared to be the property of this Grand Chapter : and the Grand Officers, or any one of them, may demand, recover and take possession thereof, for the benefit of the Grand Chapter.

## ARTICLE XV.

The Grand Chapter shall have, and is hereby declared to have, power and authority from time to time, to pass and enact all such Bye-Laws, Resolutions and Edicts, and to do all other acts and things for the government of itself, and all subordinate Chapters and Lodges, not inconsistent with this constitution, as may be deemed expedient.

## ARTICLE XVI.

A majority of the Chapters under the jurisdiction of this Grand Chapter, have power and authority from time to time, to call conventions for the purpose of altering or amending this Constitution.

Convention met according to adjournment. Comp. Arnold in the Chair.

*Resolved*, That a committee, composed of M. E. C. STRANGE, M. E. C. SMITH, and E. C. HUNTER, be appointed to draught Bye-Laws for the government of the Grand Chapter, and report at next meeting.

*Resolved*, That the G. H. Priest issue letters of dispensation to the several Chapters subordinate to this Grand Chapter, empowering them to work until the next meeting of the Grand Chapter, and to such other Chapters as may solicit admission, signifying their assent to come under the authority of this Grand Chapter.

*Resolved*, That the thanks of this Convention be presented to the officers and members of the Phoenix Lodge, for their liberality, in granting to them the use of their rooms.

*Ordered*, That a ticket be granted to Comp. D. Jordan, for his services as Steward of this Convention, signed by the G. H. P., authorizing him to receive from the G. Treasurer the sum of thirteen dollars, and that the thanks of this committee, be presented to Comp. Jordan for his polite attention to the Convention during its sitting; and that a similar ticket be granted to Comp. Lumsden, for his services as Tiler.

*Resolved*, That such of the members of this Convention, as may be members of the Legislature of North Carolina, at its next session, be requested to obtain a Charter of Incorporation for this Grand Chapter.

*Resolved*, That one hundred copies of these proceedings be printed, and be distributed among the Grand Officers, the members of this Convention, and the subordinate Chapters.

*Resolved*, That a copy of these proceedings be forwarded to some one officer of the General Grand Chapter of the United States, for his approbation.

Convention adjourned *sine die*.

Pursuant to the 2d Article of the Constitution adopted by the Convention holden at Fayetteville, June 21, A. D. 1822, and in the year of Royal Arch Masonry, 2352, the Grand Chapter of North Carolina convened at Mason Hall, in the town of Fayetteville, on Monday, the 23d day of June, A. L. 5823:

Companions James Townes, Alex. McRae, Joseph R. Lloyd, are appointed.

On motion, Grand Chapter adjourned till to-morrow morning at 9 o'clock.

Grand Chapter convened pursuant to adjournment.

The following resolutions were submitted to the Grand Chapter by M. E. Comp. Joseph R. Lloyd, viz :

1st. *Resolved*, That it would more fully promote the advancement of Royal Arch Masonry in this State, and the welfare of masonry in general, that the Grand Chapter should be permanently located in some one town.

2d. *Resolved*, That so much of the first article of the Constitution as prohibits any individual member from exercising more than one vote, either as proxy or otherwise, will often deprive the officers of the subordinate Chapters of their privileges of voting in the Grand Chapter, and it is therefore inexpedient and improper; and should be so far amended as to permit an individual member to represent the officers of one Chapter, but no more.

3d. *Resolved*, That the Grand Chapter recommend to the subordinate Chapters, the propriety of meeting in Convention at Tarborough, on the 23d June, 1824, for the purpose of so altering and modifying the Constitution of the Grand Chapter, as to attain the aforesaid objects, and to make such other alterations therein as the Convention, in its wisdom, may think most advantageous to masonry in general.

These several resolutions were read; and the first and third agreed to, but the second was rejected.

On motion, *Resolved*, That the Grand Chapter issue charters to the several subordinate Chapters which have acknowledged the jurisdiction of this Grand Chapter; and that the said subordinate Chapters surrender to this Grand Chapter the dispensations or charters under which they have heretofore worked.

On motion, *Resolved*, That the Grand High Priest issue dispensations to the Chapters under the jurisdiction of this Grand Chapter, authorizing them to work, until they shall have received charters.

On motion, *Resolved*, That Companion John Crusoe be appointed by this Grand Chapter (Companion Alexander Little, Grand Secretary, being absent,) to perform the duties required of the Grand Secretary, by the 9th article of the Constitution, and to make out dispensations or charters for the several Chapters now under the jurisdiction of this Grand Chapter, receiving the fees for the same.

On motion, *Resolved*, That a committee be appointed to select some suitable device for a seal to this Grand Chapter: Companions Colin McIver, James H. Hooper, Alexander McRae, appointed.

On motion, Grand Chapter adjourned until to-morrow morning at 10 o'clock.

The committee appointed to select some suitable device for a seal for this Grand Chapter, having performed the duty assigned them, report :

That on mature deliberation, they recommend to the Grand Chapter a Common Seal, three inches in diameter, to be made of copper, engraved with a representation of the High Priest's mitre, his breast-plate, the pot of manna, Aaron's Rod, the Holy Bible, and the inscription, '*Holiness to the Lord,*' as contained in the 39th page of the Masonic Chart, encircled by these words, "*Grand Royal Arch Chapter of North Carolina.*"

On motion, *Resolved*, That M. E. Comp. Robt. Strange, G. H. P., be authorized to contract for and procure a seal pursuant to the foregoing report.

The committee appointed to draft Bye-Laws for the government of this Grand Chapter, having performed the duty assigned them, report as follows, which was read and adopted.

## BYE-LAWS OF GRAND CHAPTER.

---

### ARTICLE I.

It shall be the duty of the several officers of the Grand Chapter, to attend the stated meetings thereof, either in person or by proxy.

### ARTICLE II.

The Grand High Priest, or, in his absence, the senior officer present, shall take the chair precisely at the hour to which the Grand Chapter stands adjourned; shall immediately, upon the appearance of a quorum, open the Grand Chapter in due form.

### ARTICLE III.

At every sitting of each Annual Convention of the Grand Chapter, the minutes of the preceding sitting shall be read, and, if requisite, corrected.

### ARTICLE IV.

It shall be the duty of the presiding officer, at all times, to preserve order, and to endeavor to conduct all business before the Grand Chapter to a speedy and proper result.

### ARTICLE V.

The presiding officer may speak to points of order in preference to other members, and shall decide questions of order, subject to an appeal to the Grand Chapter, by any member seconded.

### ARTICLE VI.

Business left unfinished at the last sitting, is ordinarily to be taken up first.

### ARTICLE VII.

A motion made must be seconded, and afterwards repeated by the presiding officer, or read aloud before it is debated; and every motion shall be reduced to writing, if the presiding officer or any member requires it.

### ARTICLE VIII.

Any member who shall have made a motion, may withdraw it, with the consent of his second, before any debate has taken place thereon; but not afterwards, without the permission of the Grand Chapter.

## ARTICLE IX.

On questions of order, postponement or commitment, no member shall speak more than once; on all other questions except adjournment, on which no discussion will be allowed, each member may speak twice, but not oftener, without the express permission of the Grand Chapter.

## ARTICLE X.

When a question is under debate, no motion shall be received, except to amend it, to commit it, to postpone it, or to adjourn.

## ARTICLE XI.

An amendment may be made on any motion, and shall be decided before the original motion.

## ARTICLE XII.

If a motion under debate contain several parts, any member seconded may have it divided and a question taken on each part.

## ARTICLE XIII.

A question shall not be again called up or reconsidered at the same meeting of the Grand Chapter at which it has been decided, except by the consent of two-thirds of the members present, and unless the motion to reconsider be made by a member who voted with the majority.

## ARTICLE XIV.

Every member when speaking, shall rise and respectfully address himself to the chair, and shall treat his fellow-members with decorum and respect.

## ARTICLE XV.

No speaker shall be interrupted, unless he be out of order, or for the purpose of correcting mistakes or misrepresentations.

## ARTICLE XVI.

If more than one member rise to speak at the same time, the presiding officer shall decide which shall first be heard.

## ARTICLE XVII.

If any member act in any respect in a disorderly manner, it shall be the privilege of any member, and the duty of the presiding officer, to call him to order.

## ARTICLE XVIII.

If any member consider himself aggrieved by the decision of the Grand High Priest, or other officer presiding for the time being, it shall be his privi-

lege to appeal to the Grand Chapter, and the question on such decision shall be taken without debate.

ARTICLE XIX.

All committees shall be appointed by the presiding officer for the time being, except when otherwise directed by the Grand Chapter.

ARTICLE XX.

The person first named on any committee shall be considered as the chairman thereof, whose duty it shall be to convene the committee, and in case of his absence or inability to act, the second named member shall take his place and perform his duties.

ARTICLE XXI.

The yeas and nays on any question shall not be recorded, unless it be required by one-third of the members present.

ARTICLE XXII.

No member shall retire from the room while the Grand Chapter is sitting, without the permission of the presiding officer; nor return home without the consent of the Grand Chapter.

ARTICLE XXIII.

Visiting Companions shall not vote on any question or petition before the Grand Chapter; but may be heard in debate, with the consent of a majority of the members present.

ARTICLE XXIV.

The Grand High Priest, or, in case of his death or resignation, the Deputy Grand High Priest, shall be authorized, at all times, to draw upon the Grand Treasurer for any sums of money that shall be necessary to defray the expenses which may be incurred by the Grand Chapter.

ARTICLE XXV.

The Grand Treasurer shall deliver to the standing committee immediately preceding the annual election of officers, a statement of all accounts, and of the funds of the Grand Chapter, and also of all delinquences.

ARTICLE XXVI.

All subjects on which questions are to be taken (except such as are especially provided for) shall be decided by a majority; and in cases of an equal number of votes, the motion, question or resolution, shall be considered as lost.

## ARTICLE XXVII.

The Most Excellent Grand High Priest, Deputy Grand High Priest, Grand King and Grand Scribe, shall form a standing committee, any two of whom may act; whose duty it shall be to adjust all claims against the Grand Chapter; to examine the Treasurer's books and accounts annually, and at every election of officers to report to the Grand Chapter the state of the funds: to which committee all applicants for charity shall be referred; and for that purpose the said committee shall have authority to draw on the Grand Treasurer.

## ARTICLE XXVIII.

The members of the Grand Chapter shall at every meeting appear in Royal Arch Sashes, and plain white Aprons.

## ARTICLE XXIX.

Those persons officiating as Grand Tiler and Steward, shall, for the services of Grand Tiler, receive one dollar for each sitting of the Grand Chapter, and for the services of Grand Steward, shall receive for each member present, at the different sittings of the Grand Chapter, twenty-five cents.

## ARTICLE XXX.

The Grand Secretary, in addition to the duties prescribed in the 9th article of the Constitution of this Grand Chapter, shall transmit to each member of the Grand Chapter, annually, a copy of the proceedings thereof; for which service he shall receive the sum of ten dollars per annum.

## ARTICLE XXXI.

The Bye-Laws shall be read at the commencement of every regular meeting.

## ARTICLE XXXII.

There shall be no alteration or amendment of these Bye-Laws, except with the concurrence of two-thirds of the members present at an annual meeting.

Your committee beg leave further to report, that at the last Annual Convocation of the Grand Chapter, there was no difference in the situation of the aforesaid Chapters, from that of all other Chapters, under this jurisdiction ; and that all other Chapters were represented in that Convocation, and cheerfully submitted to the authority of this Grand Chapter, and acknowledged themselves bound for dues from June, 1822, the time at which this Grand Chapter was formed. Your committee are of opinion, that the negligence of the said Chapters in not sending representatives to the last Annual Convocation, is not a sufficient excuse for not paying their dues from June, 1822 ; and your committee can see no good reason why the said Chapters should be excused from the payment of any part of said dues.

The committee, appointed to report some suitable method of showing that respect which is due to the memory of our worthy and most excellent Companion, Robert Rankin, recommend the adoption of the following resolutions, which were unanimously adopted, viz :

*Resolved*, by the Grand Chapter of North Carolina, that we deeply deplore in common, with the whole Masonic Fraternity, the loss which masonry at large has sustained, by the death of our most excellent Companion, Robert Rankin, late Grand Scribe of said Grand Chapter, and Past High Priest of Concord Chapter, No. 1, of Wilmington.

*Resolved further*, As a testimony of our esteem for the eminently distinguished services of our late most excellent Companion, Robert Rankin, we do present his widow with the sum of seventy dollars, in a medal, a piece of plate, or otherwise at the discretion of the committee; and that a committee of two be appointed, to carry the same into effect.

On motion, *Resolved*, As an amendment to the 16th article of the Constitution, that the following words be added, to-wit: "except as to the location of the Grand Chapter, which shall require a concurrence of two-thirds to alter."

On motion, *Resolved*, As an amendment to the 11th article of the Constitution, that the word "Month," be stricken out, and the words "meeting previous," be inserted.

On motion, *Resolved*, As an amendment to the 1st article of the Constitution, that the following words be added, viz: "*Provided*, the Grand High Priest shall have two votes, where the number of votes happen to be equal, otherwise, he shall have but one vote; and no Companion or brother, can represent more than one Chapter or Lodge at the same time.

HALL OF EUREKA CHAPTER, No. 7, NEWBERN, N. C.,  
June 18th, A. D., 1825, R. A. M. 5825.

A Convocation of Eureka Chapter, No. 7, took place this evening pursuant to order of the Most Excellent High Priest. The constitutional number being present the Chapter was opened in due and ancient form, when the following report was presented by M. E. Companion Thomas A. Pasteur, King, viz :

*To the Most Excellent High Priest, Excellent King, Excellent Scribe and other officers and members of Eureka Chapter, No. 7, of Royal Arch Masons, Newbern :*

COMPANIONS: I have perused the communication of Bro. Robt. T. Daniel, addressed to the several Lodges and Chapters of this State, with that attention I conceived it to be entitled, and humbly beg leave to report :

That I conceive the manner of Brother Robert T. Daniel's application for a donation from our funds to be unmasonic; inasmuch as he must have been aware that his *masonic character* could not have been known to most of the Lodges and Chapters in this State, unless his circular had been accompanied by proper authentic vouchers of that fact; nor do I at this time know him as a Mason of any degree above that of Master. It was therefore highly improper in him to make such application, unaccompanied with such vouchers, in any other character, than as the mere agent of that religious society for which he was acting.

I am willing, however, to believe, that he has not *intentionally* been guilty of any contempt for the established usages of Masonry, but has rather been led into error by an *ardent* and *laudable* zeal for the promotion of the interests of that religious association of which he has the honor to be considered a useful and worthy member.

But independent of any consideration as to the mode of his application, I am well satisfied that there are other more and important reasons for not complying with his request.

The funds of every regular Lodge and Chapter are *pledged* by the fundamental principles on which they are established, as well as by the *tenets* of our profession, to the exclusive dispensation of *physical comfort* to the *worthy, unfortunate* and *distressed*. To aid and assist such (under certain prescribed regulations) is among the most important and imperious duties that devolve upon us; and which it would be impossible for us duly to perform, were we to lavish our funds on other objects which do not come within those specific duties; and which I am confident were never contemplated by the primitive founders of our order.

The Masonic fraternity comprises individuals, not only of almost every religious sect in Christendom, but also Jews, Mahometans and others. To preserve order, harmony, and fellowship amongst materials seemingly so discordant, may, to the world appear impossible; yet it is, and *ever shall be* the undeviating aim of every mason. It is to effect this great and *important* point, that religious disquisitions and political brawls are excluded from our assemblies—that the grating sound of discord may never be heard within the portals of the Masonic Temple. As our institution is one purely benevolent, so far as benevolence is instrumental in contributing to the needy and distressed, and being founded on, and supported by Divine revelation, guided by its precepts, and controlled and directed by the hallowed principles of the purest morality, it would indeed be uncharitable in us in this instance to exhibit a preference for any sect of religious professors, by granting to the request of Bro. Robert T. Daniel, what circumstances at another time, might compel us to withhold from applicants equally worthy. Let the precedent once be established and we should justly merit the bitterest reproaches of those who are denied our favors. Yield but to this solicitation, and you will not only have incurred the imputation of partiality, but will have been guilty of a palpable dereliction of the established principles of Masonry. Grant but to one, and all will reasonably conclude that they have equal claims on our generosity for the promotion of similar objects; and after our treasury shall have been *drained*, the *first* denial of a similar request, will, from the very nature of the case, become a prelude to confusion, by introducing within our sacred walls, the rancorous spirit of

religious altercation, to the disturbance, if not to the destruction of that harmony and social order which are so essential to our existence as a society.

I have long known that the generality of the religious society (Baptists) to which Bro. Robert T. Daniel belongs, entertain no very favorable views of the Masonic institution; and possibly, as he seems to think, their good opinion might be conciliated by a liberal donation from our funds; but it is to be hoped that the fraternity, so long as they are conscious of their own rectitude, will never *stoop so far from the established dignity of our order*, as to consent to purchase it, by a *sacrifice of their principles*. Prompted by *charity*, I can freely excuse the frailties of those who condemn us without a cause, and hope that the Supreme Grand High Priest above, who knoweth the *secrets* of all hearts, will also forgive the errors of such "*as know not what they do*."

While as individuals we might feel a willingness to lend our aid to promote the object for which Bro. Daniel is soliciting donations, and I doubt not there are many of the Masonic family who will forward to him some testimony of their individual devotion to the cause in which he thinks himself so worthily and zealously engaged, yet I do not hesitate to declare it as my opinion, that no part of the funds of our Chapter ought to be appropriated to purposes in which as a body we can take no active part, and for objects over which we can have no shadow of control.

To guard against the establishment, at any future period, of a practice so fraught with error, as would be such an appropriation, permit me, respectfully to recommend that this report be entered on the records of our Chapter, a copy thereof forwarded to Bro. Robert T. Daniel, and also one to the Most Excellent Grand High Priest of the Grand Chapter of North Carolina.

*Circular Address to the Grand Chapter, Grand Lodge, the different Chapters and Subordinate Lodges of Free Masons in North Carolina—greeting:*

BELOVED BRETHREN:—Accompanying this address you are presented with a copy of the Minutes of the North Carolina Baptist Society for Missions, Foreign and Domestic. Page the 5th, and resolutions 2 and 5, embraced in brackets, will show to your highly respectable body that I have the honor of

serving that Society as Agent throughout the State; in which office I have acted three years, and labored much to accelerate its interest and usefulness. In which term I have formed forty-five Auxiliary Societies; twenty-four of which are reported in these minutes—the residue have been organized since the last annual meeting, and will be reported in the minutes of the next. Aided by the funds of these societies, public collections and private donations, we have been enabled to send forth seven domestic missionaries, whose labors have been wonderfully succeeded by Divine agency. A number not less than three thousand have been added to our churches by baptism within the last three years in this State; by which we are greatly encouraged to pursue our pious design with energy. In this Union of States, there are, of our denomination, three hundred thousand members, divided into thirty-five hundred churches; the number of clergymen only about twenty-five hundred. This leaves one thousand churches without supply. Besides many sequestered neighborhoods and sections of our State are almost totally deprived of the Gospel. To change this lamentable scene, our present efforts are aimed.

Permit me, as a member of your benevolent society, to solicit a donation for the above purpose. This request is intended not only to aid our funds, but to furnish me with arguments to conciliate the minds of many Christian friends to the noble institution of Masonry. Most excellent will your fruit of charity appear, when sent up to the House of God to aid the cause of Missions. I have privately consulted many Masonic brethren on the propriety of sending an address to the different Chapters and Lodges of this State on the above subject. They highly approve the plan. I hope, my affectionate brethren, you will gratify me in this request, with as much liberality as the state of your funds and other calls will justify. Should the donation you make even be small, yet, coming from the Lodges, it will have much better effect on the public mind than if the same sums were to be given by individuals of our fraternity; especially as the sums given by each Chapter and Lodge, appearing in our public minutes, will go to show to Christians and others that we are a benevolent people, and true friends to the Christian cause. I wish this circular and minutes spread before the brethren as soon as possible, and a letter, covering your liberality, directed to me at Raleigh; which letter and money shall be presented to the Board of Missions at its next annual meeting, and published in the minutes; and each Chapter and Lodge furnished with a copy. This will prepare me with an ample fund of arguments for removing many prejudices against our noble institution; to which I feel strongly attached, and bound ever to vindicate and support.

Your committee have further considered the present state of Wadesboro' Chapter, No. 6, Anson county, and after due deliberation report, that they conceive the present number composing said Chapter to be less than is desirable, but upon the information of a worthy Companion, your committee are satisfied that they are possessed of materials well calculated to promote the interest of the Craft, and therefore recommend that an indulgence be granted to said Chapter until the 23d day of June, 1826, to make their report.

## FOURTH ANNUAL CONVOCATION, &c.

---

At a meeting of the Grand Royal Arch Chapter of North Carolina, begun and holden at Tarborough on the 23d day of June, A. D. 1826, A. L. 5826.

### PRESENT:
